If you miss this December, you'll wait another year for your refund.

### Two ways to pitch in ... why not do both?

*First:* Decide on a convenient monthly amount to be processed through your Visa or MasterCard. Your contribution will appear near the end of every month and in February, you'll receive your official tax receipt.

**Second:** Take full advantage of the 2006 tax rebate – especially important if you haven't yet made your maximum contribution this year! Make your one-time contribution either by card or by cheque. If you prefer a credit card, your amount will be processed in late December. If a cheque is more convenient, be sure to date it no later than 29 December to qualify for this year's tax rebate.

Either way, indicate your choices by completing and mailing the coupon below.

Be sure to enter your name and address - we cannot accept anonymous contributions. You must be a citizen or Canadian Resident to contribute.

t our last general meeting in June, we created

the new provincial riding of Pickering-Scarborough East with provincial borders now matching the federal ones. However, the federal and provincial riding associations remain separate entities, governed by different Acts, and with separate executives, and finances.

Key differences exist in our financial situations. Your membership fees go to the provincial party, which shares a minuscule percentage with the provincial riding association. For now, the provincial party is allowing to keep 100% of money we raise, but this may well change at our convention – 26-28 Jan, 2007 in Toronto).

The federal party also gets a share of your membership fees but our local federal riding association gets *nothing*. However, we keep every penny we raise locally.

Both levels of government have tax rebates for contributions to political parties. These are totally separate, so your provincial contribution doesn't affect your federal rebate and vice-versa. However, both are included with any campaign contributions to determine your total annual federal and provincial contributions.

# Everyone's help is needed now **Provincial election is next fall!**

Provincially, you can contribute up to \$300 by the end of this year and get 75% of it back. For example, a contribution of \$100 will only cost you \$25 after the income tax rebate. Federally, you can contribute up \$400 in a year while still getting 75% back so a contribution of \$400 only costs you \$100.

Because these are separate, you can contribute both \$300 provincially and \$400 federally and still get 75% back on each amount.

So I am asking you to give generously – preferably well before December 29th (the last day we can expect to get your contribution deposited for credit this year) – to help us prepare for the expected federal and confirmed provincial elections in 2007.

There is a pledge form below and a return envelope enclosed. I know that it seems everyone is asking you for money these days, but you are receiving this appeal because you know how important it is to elect more New Democrats. Your contribution, no matter how large or small, goes 100% towards helping us retake this riding.
